### 5. 产品寿命终止管理 Product life termination management

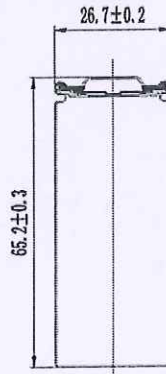
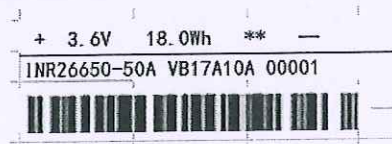


图 1 电芯外观尺寸
